



TUITION & FEES INFORMATION 2024-2025

INITIAL FEES (NEW STUDENTS ONLY)

Non-refundable Application Fee: €350

Non-refundable Registration Fee: €1500

TUITION

The tuition covers the costs of classroom instruction, in-school supervision, curriculum, textbooks on loan, supplies, educational materials, standardized testing, professional development for staff, IB teacher certification, and ICSV library privileges and subscriptions. Tuition is prorated according to the start date/withdrawal date of the student.

CAPITAL ASSESSMENT FEE

The annual Capital Assessment Fee covers the costs related to ICSV's building and grounds: mortgage, utilities, maintenance, and improvements. The Capital Assessment Fee is due annually in full and will be invoiced with the initial invoice. This fee is **not** prorated according to the student's start date/withdrawal date.

SUPPLEMENTAL FEES

Supplemental fees are charged, as applicable to each student. **Essential Supplemental Fees** are required for enrollment to cover the costs of Student Support Services (SSS), including Learning Support (LS) and English Language Learner (ELL). Essential Supplemental Fees are prorated according to the start date/withdrawal date of the student. **Non-Essential Supplemental Fees** are available after initial enrollment to cover the costs for the IB Diploma Programme and student activities (sports participation, after school care, special trips, lunch program, and college entrance exams).

SUPPLEMENTAL FEES (CONTINUED)

Learning Support (LS)

ICSV offers instructional support to students with a variety of mild to moderate learning challenges. Enrollment in the Learning Support Program is based on individual student needs, program capacity, and availability of the required support. Students with diagnosed learning challenges are provided with Individual Learning Support Plans, outlining their specific goals and accommodation needs.

English Language Learner (ELL)

The English Language Learner Program assists non-native English-speaking students in raising their level of academic proficiency in English. Students who require ELL services should apply and enroll as early as possible, as our ELL capacity is limited.

MULTIPLE STUDENT DISCOUNT

Families with three children concurrently enrolled at ICSV will be granted a tuition discount equal to ten percent (10%) of the third child's tuition. For the fourth and each subsequent child, the discount increases to twenty percent (20%).

TUITION AND FEES PAYMENT OPTIONS

Invoices will be sent out on the 15th of each month August through May, prior to the due date.

- A. One total payment: **due October 1st**
- B. Two semester payments: **due September 1st and February 1st**
- C. Quarterly payments: **due September 1st, November 1st, February 1st, and April 1st**
- D. Ten monthly payments: **due each month, September through June***

* Note that the ten monthly payment option requires a signed direct debit authorization form, which authorizes ICSV to draft the monthly payments on the 5th day of each month, September through June, from a designated personal bank account of parents/guardians. Cash payments are not accepted for the ten monthly payment option.

* The ten monthly payment option is only available for students starting on the first day of the school year. Students starting school after the first day of school can only select payment options A-C.

MID-YEAR ENROLLMENT

The Capital Assessment Fee is due in full, regardless of the student's start date/withdrawal date. Annual tuition (including Essential Supplemental Fees) for late enrollment are payable according to the following schedule:

LATE PAYMENT POLICY

Tuition must be paid in accordance with the Enrollment Contract that is signed when enrolling or re-enrolling the student. Students of families who are behind on payments for more than one quarter will be dis-enrolled, and the school contract will be terminated by way of written notice sent to the parent/guardian.

WITHDRAWAL POLICY

A written request for student withdrawal must be submitted thirty (30) days before the student's expected last day of attendance. All tuition for the current month of attendance as well as the remaining Capital Assessment Fee for the entire year must be paid and school resources must be returned before official student records are released. Student records including the ICSV diploma will not be released until all tuition and fees have been paid in full.
